2. Scope of Work:

- 2.1 "Land Lab" shall perform The soil chemical lab analysis for qty. of 350 samples under the same technical specs sated in our LOA no. MEMO 70/20 PRO including the followings chemical tests:
 - CaC03
 - Sulphate Ion
 - Chloride Ion
 - Total Salt
 - PH
 - Organic Impurities in Soil.
- 2.2 "Land Lab" should provide us with all needed basic technical reports and additional detailed technical report the same as previously submitted as per LOA no. MEMO 70/20 PRO
