The Faculty of Law – a Brief note :

Assiut University is the first university in Upper Egypt. It includes 18 practical and theoretical faculties. Faculty of Law, being one of the earlier Faculties, was inaugurated in 1975. From that time on, the faculty has carried an unwrittem but known mission for all the university employees and the surrounding community. This mission was made clear in 2005 by the Dean, Heads of departments, some faculty members and employees and it was approved by the faculty council. This mission was published this year 16/4/2007 and will be printed in the faculty guide and on its web site, and will be considered for an update every 5 years.

First: The Mission

In accordance with the mission of Assuit University, Faculty of law aims at the following :

- 1- Graduating qualified and trained cadres to practice legal works which relate to both Public & Private laws, Islamic legislations, Economics and Public Finance.
- 2- Spreading knowledge and deepening academic research in these specializations.
- 3- Participating in community and environmental developments through the spreading legal awareness, providing legal consultations and training in the mentioned specialization fields to all the working organizations in the surrounding communities.

Faculty's mission would be subject to updating every years :

The faculty is considered a source of knowledge in law and legislation. It is also a place of having generations capable of working in all legal organizations and institutions, and free professions in local and international communities.

Strategic Aims of the Faculty:

- 1- Preparing an academic program that satisfies the modern developments in legal systems and guarantees providing local and regional work market with legal cadres acquainted with society problems and capable of solving it by legal methods.
- 2- Preparing the faculty of law to be a legal experience center which provides the surrounding community, governmental institutions and civil community institutions with experiences.
- **3-** Reviving morals, traditions and national heritage and deepening the feeling of belonging to home country.
- **4-** Promoting educational, research and administrative programs and developing base structure (material and human).
- Developing research plans in the faculty to contribute in practical solutions of the society problems.
- 6- Creating administrative mechanisms for continuous scientific cooperation between Faculty of Law and all other faculties and legal organizations inside and outside Egypt in the legal fields.

Second: Administration:

1- Organizational Structure

Law of Universities Organization, issued in 1972, defined tasks and duties of every mentioned council. Hence, members of the scientific departments councils, the faculty council and Vice-Deans cooperate with the Dean in planning the strategic issues, setting the general policy of the faculty and in making any amendment or arrangement on the organizational structure of the faculty. The Dean, Vice-Deans and heads of departments handle the work in the faculty.

The organizational structure of the faculty includes the following administrations:

- **1-** The Faculty Registrar.
- 2- Higher Studies & Cultural Relations Administrations
- **3-** The library .
- 4- Financial Affairs & Accounting Administration (Purchasing, stores and treasury Administrations.)
- 5- Faculty council secretarial Administration.
- 6- Administrative Affairs Administration. (Personal Affairs Administration).
- 7- General services Administration
- 8- Youth care Administration
- 9- Educational Affairs Administrations.
- 10- Planning and Following Administration
- 11- Public relations Administration.
- 12- Faculty members services Administration
- 13- Graduates' Affairs Administrations
- 14- Security Administration
- 15- Computer Center.
- 16- Legal Affairs Administration

These Administrations handle all the managerial, financial and service tasks which help the scientific Depts. to accomplish their tasks. Each Administration works under the leadership of a director and number of employees.

2- Selection of Academic Leaders:

(A) **Dean selection:**

The University President appoints the faculty Dean or the institute affiliated to the university for renewable three years:

In case of non- existence of professors in the faculty or the institute, the University President has the right to appoint any professor from the faculties or institutes affiliated to the university or appoint any assistant from the same faculty to perform the tasks of the Dean.

The University President has the right to depose the Dean before the end of his working period by an effect resolution after the approval of the university council if the Dean violated the University Laws.

(B) Vice- Deans Selection:

Each faculty or institute has two Vice-Deans who help the Dean in administering the faculty or the institute affairs. When the Dean is absent, the most senior Vice-Dean handles his tasks. One of them handles the Educational Affairs and the Students' Cultural and Social Affairs while the other handles Post Graduate Studies and Research affairs.

It is allowed to appoint a third Vice-Dean to handle the community services and environmental development affairs and he becomes a member in the council of community service and environment development.

In some faculties or institutes, it is allowed to appoint one Vice-Dean by a resolution from the University President after the approval of both the faculty council and the university council.

The appointed Vice-Dean should be one of the faculty professors as per the University President resolution after the Dean nomination for a renewable three years.

(article 47-Law of Universities Organization). **C- Heads of Departments Selection:**

The Head of the department council is appointed from the most senior three Professors in the department as per the resolution of the University President after the Dean's nomination for a renewable three years. This Law is considered inapplicable in case of existing less than three professors and the most senior professor is appointed as Head of the department council.

In case there is other professors in the department, the Head of the department council is considered retired when he is appointed as the faculty Dean or Vice- Dean.

However, if there is no professor at the Dept. The most senior assistant professor handles the task of "Head of the Dept" in this concern, he has the right to attend the sessions of the faculty/ institute council except when it is discussing the appointment of a professor.

If there was no professor but a foreign one, he could handle the task of "Head of the Dept." only if required and according to a decision from the University President after consulting the Faculty Dean (article 56 of Law of Universities Organization).

3- The efficacy of polices, systems and practices:

First: Questionnaires

1- Dean's questionnaire:

A- Objective: Recognizing the faculty members opinions about the Dean's performance in order to be developed.

B. Procedures: This questionnaire is done by a previously prepared pattern once per year, it is discussed and the results are presented in the presence of the Dean, the faculty members, and to the faculty council.

C. Obstacles:

- 1- Deficiency of the number of participants
- 2- Multiplicity of items in the questionnaire and the need for revising and reformulating it.
- 3- Inaccuracy of filling the questionnaire

2- Head of Department questionnaire:

A. Objective: Evaluating the performance of the Head of Department as he is the effective element in improving the educational process.

B. Procedures:

It is done by a previously prepared pattern, once per year. It is discussed and the results are presented in the presence of the Head of department and the faculty members and to the faculty council.

3- Questionnaires of specific administrations of the faculty

- **A. Objective:** Evaluating the performance of the faculty administrations through the academic year and recognizing its suitableness for the improvement of the educational process.
- **B. Procedures:** Distributing the previously prepared patterns on various administrations to know their opinions through this questionnaire. Then collecting them and getting out the results and presenting them to be discussed in the faculty council.

Second: Suggestions & Complaints box

- A. Objective: Receiving complaints and suggestions of students and employees.
- **B. Procedures:** Periodically revising the students & and employees complaints and suggestions to improve the educational process.

Third: Regarding the students' opinions

A. **Objectives:** Evaluating the performance, improving curricula teaching and developing the educational process.

- **B. Procedures:** This mechanism is done in every questionnaire related to the course once every semester.
- C. Participants: Faculty students (Bachelor's stage).

Fourth: The scientific conference of the faculty and the department

(A) Formation:

The faculty members, their representatives from their assistants with a percentage that does not exceed 30% of the faculty members and students with a percentage that does not exceed 20% of the students.

(B): Procedure: It is held once every academic year. As for the department, it is held once every semester.

(c) **Specializations:** The scientific conference concerns with teaching and discussing all educational and scientific research affairs in the faculty or the department; also, evaluating the set systems in order to trace the educational and scientific progress and the requirements of the community. (article 50, 63 Law of Universities Organization).

(D) Recommendations of the scientific conference:

- 1- Assuring the importance that the exams should include questions that measure the cognitive aspects and skills of the students; and recognizing the students abilities and ways of distinguishing among them.
- 2- Publishing the faculty mission among the faculty members, their assistants and all the faculty employees and students.
- 3- Assuring the importance of meeting the set dates of finalizing correction works and the importance that the course professor should participate in correction process as long as there is no legal excuse that may prevent him from the correction works.
- 4- Restricting seconding from outside the faculty to participate in correction work.
- 5- Assuring the importance of team-work to carry out the project of "establishing an internal system for the quality assurance in the faculty".

- 6- Photocopying the supporting grades sheets and distributing them among control members.
- 7- Considering the fast formation of exam and correction committees .
- 8- Assuring the importance of the non-repetition of curricula in Post Graduate diploma.
- 9- Reviewing the evaluating systems of Post Graduate students to recognize the reasons of variation in success percentages among diplomas.
- 10- Considering the preparation of the departments research plan.

Fifth: Faculty council

Specialization:

The faculty council handles the following issues:

- 1- Planning, coordination, organization and reviewing
- 2- Executive matters.
- 3- Various issues referred to it from the University council.

Sixth: Departments councils

Specialization:

Reviewing all scientific, academic, administrative and financial affairs related to the department, mainly the following issues:

- 1- Designing the general policy of education and scientific research in the department.
- 2- Establishing the work system in the department and coordinating the various specializations in the department.
- 3- Defining the academic courses and their scientific content.

- 4- Defining books and references in the course of the department and help the students to get them.
- 5- Establishing and coordinating research plan and distributing the supervision.
- 6- Suggesting the appointment of the faculty members, seconding and transferring them; and sending them to scientific missions and conferences. Also, suggesting the permission for professors to bear study leaves.
- 7- Distributing lectures and scientific exercises and seconding from and to the department.
- 8- Appointing assistant lecturers and demonstrators, seconding, transferring, and sending them to missions or foreign scholarships.
- 9- Distributing the exam works and forming the exam committees related to the department.
- 10- Granting rewards to Post Graduate Students
- 11- Appointing supervisors on theses, forming arbitration committees and granting Master's and PhD degrees.
- 12- Discussing the annual reports of the Head and Vice-Heads of the department council. Also, discussing the exam results and the recommendation of the department and the faculty scientific conferences. Again, evaluating the study systems, the exam and scientific research in the department, revising and defining them in the framework of scientific and educational progress and the community requirements.
- 13- Following up the execution of the general policy of education and research in the department.

Seventh: Specific committees

Students Affairs Committee:

Specializations: This committee handles the following issues:

- Deciding upon the students' transference, enrollment ceasing and accepting exam excuses.
- Organizing the practical training of the students
- Following up the exam results and studying their statistics and the reports of exam committees concerning their levels. Also, presenting the required recommendations to the faculty council.
- Organizing rewards and scholarships.
- Following up cultural, athletic and social activities and providing suggestions to improve their level.
- Organizing a scientific policy for the students.
- Facilitating the printing and publishing of academic books.
- Encouraging the formation of a scientific association to increase the number of faculty members and organizing scientific visits and activities for the students and the environment service projects related to their specializations.

2- Post- Graduate studies and research committee:

Specializations:

This committee handles the following issues:

- Preparing tentative studies and scientific research in the faculty and following up their execution.
- Coordinating the scientific research among various department of the faculty.
- Preparing the budget project of scientific research in the faculty and distributing it according to the suggested programs supplying the necessary facilities to execute the research programs.
- Following up the programs and systems of the Post-Graduate studies and the University degrees in the faculty, to keep steps with the scientific progress.

- Receiving the scientific problems from the different authorities and distributing it on the departments to perform the necessary research to solve it.
- Supervising the scientific publishing affairs in the faculty and collecting the scientific research of the departments publishing distributing and exchanging it with the concerned authorities and the workers outside the university.
- Checking the environment of the Post –Graduate students, transforming them, transferring, enrollment ceasing and the exams excuses.
- Checking the suggestions of the departments councils concerning registration of diploma, Master's and Ph.D theses and the supervisors reports and appointing the arbitration committees on the theses before presenting it to the faculty council.

3-Committees of laboratories and the scientific devices:

Specializations: It handles the following issues:

- Setting a program to support the laboratories and the scientific devices at the faculty, and to ensure the raising of scientific study level.
- Setting a system to use the scientific devices to facilitate its use.
- Preparing the laboratories annual budget project in the faculty according to the rate of student usage, counting the existing devices determining its validity and stating required devices and materials to meet it and setting a system to renew and maintain the existing ones.

4- Committee of external cultural and scientific relations

Specializations: It handles the following issues:

- Setting a plan for faculty missions and the study leaves according to department

suggestion.

- Setting a policy to send the faculty members to scientific missions to follow the scientific progress in their specialization field.

- Suggesting a general program for the conferences, scientific courses and seminars that the faculty participates in and publishing research and reports.

5- Libraries committee:

Specialization: It handles the following issues:

- Drawing up plans to encourage faculty staff members to write textbooks and to make them available for the students reach.
- Setting a budget project for the library to meet the faculty requirement from the most recent textbooks and references.

6- Community service and environmental development committee: Specialization:

It handles the following issues:

- Preparing plans and programs that facilitate the achievement of the faculty role in community service and environmental development.
- Establishing and managing special units that offer their services to external users.
- Organizing conferences, scientific seminars, and lectures that aim at serving the community and developing the environment.

Eighth: Annual report of Administrative Staff

Objective:

Evaluation of workers performance and setting a system of rewards and penalties.

Ninth: Quality Assurance Unit

Specialization:

1- Executing quality assurance strategies set by the center inside the university.

These strategies are approved by the University Council regarding the role of the faculty Departments, Administrative units and special centers at the faculty.

2- Setting mechanisms that lead to quality assurance inside the Faculty like:

A- Description of academic programs and curricula and their reports every academic year. Also the preparation of annual faculty report Also the training of faculty staff members on using and filling these reports along with setting work plans to overcome the defects of programs and curricula.

B. Setting the academic standards and reference standards for the different faculty programs.

C. Reviewing the implement of work plans and informing the faculty Dean after its completion.

D. Supervising the distribution and analysis of questionnaires results that help in the evaluation of the quality of program and curricula by students and staff members.

E. Acquainting staff members, their assistants, students and administrative Staff with quality assurance mechanisms and measuring their belief in these mechanisms.

F. Reviewing the research activities of staff members and analyzing the faculty performance in this concern.

G. Maximizing the faculty performance in the field of community service and environmental development.

H. Enhancing the relation between faculty and graduates.

I. Maximizing the role of the different departments and special units in the faculty.

3- Reviewing the faculty departments/ academic programs and the ability to require

funds from an internal or external authority and supervising the setting of strategic selfstudy required by the granting authority in conformity with its standards

4- Extent of responsiveness to changing priorities and emerging needs.

- The organizational framework consists of four scientific Depts. and needs to reconsider. Therefore, it is recommended to separate scientific Depts. so that each specialization is to be detected in an independent Dept.

- Changing some Administrative Structures inside the faculty such as cultural relations and post-Graduate studies.

- Magnifying the role of graduates Affairs Departments with Students Affairs Dept. and establishing a section inside the Graduates' Affairs Dept. to contact graduates and review their effectiveness in the labor market.

5- Contribution of recent improvement /enhancement activities to the strategic objective and plans.

- Computer courses designed for staff members their assistants and admin. Staff.
- TOEFL courses for staff members assistants.
- Stating the project of "Automated Management" in cooperation with Faculty of Engineering
- Automation of control works and results announcements.
- Courses concerned with the rehabilitation of faculty staff (project of abilities development).
- Courses concerned with the rehabilitation of employees,

- b. Computer services at the faculty: Additional computer lab will be added.
- c. Moving the administrations providing student services to larger places.
- d. Accomplishment of electronic administration services (students may be able to pay the university fees via internet.)

Fifth:- Research plans.

- Setting an authentic research plan in all academic departments. (integration among departments should be considered) while yet pursuing research projects complying with the faculty mission and educational development.
- Establishing a program to encourage and support the research activity of faculty member to help them in conducting joint research with foreign universities.
- Finding a mechanism to provide financial support to publish the academic research in national and foreign periodicals.

Sixth:- Development of the professional performance at the faculty.

- setting plan to guarantee continuous training of the administrative team of the faculty through training course.

Seventh:- social participation.

- Taking necessary actions and procedures to advertise the center of the arbitration at the university via advertisement through the newspaper 'Waqa'ea Al Masryia,' and a widely spread daily news paper.
- Supporting the role of the legal studies center for society services.
- Strengthening the relations with lawyers' syndicate and judicial authorities.

Eleventh : Suggestions to improve the Revision and Reporting process(include Effectiveness of Models and the Guiding Manuals on the level of the Course,the program and the Establishment):

The process of Reviewing and Reporting in Faculty of Law still at its initial process so its improvements will be taken into consideration later after getting feedback the Effectiveness of the Models and the Guiding Manuals affiliated with the Reviewing and Reporting Process.
